

## MYHOMECOURT 2022DESIGNED BYARTIST LOIS HARADA; NEWOUTDOOR BASKETBALL COURT ATDAVIS PARK

# PUBLIC LAUNCH EVENT WITH MAYOR ELORZA: TUESDAY, SEPTEMBER 20TH, 4:30 – 6PM

PROVIDENCE, RI—

At a public launch, non-profit My HomeCourt [MHC] and Providence College Galleries [PCG], in partnership with Providence Parks, will unveil a newly refurbished and designed public basketball court at Davis Park in the city's Smith Hill neighborhood. MHC partners with Providence Parks and PCG, whose support and love of public art and basketball are essential to MHC's mission. The basketball court will feature a court mural designed by Providence-based artist Lois Harada.

Lois Harada (b.1988) is a printmaker bridging fine art and commercial printing in Providence. Her artwork utilizes commercial production techniques and equipment to create printed editions that are meant to be affordable and accessible to a wide audience. Harada's projects are often political and employ the power of text to navigate histories, interrogate ideas, and frame responses to issues. Some of her most potent work centers on political issues past and present, ranging from banners that explore local current issues to historical injustices, such as the long-term the internment of Japanese Americans during the Second World War.

PCG commissioned Harada to create the large-scale court mural artwork. Kate McNamara, who works as both a curator for PCG and executive director of MHC, curated the artwork with technical assistance provided by PCG design and communications associate Elizabeth Corkery.

McNamara explains that she "invited Harada to design the artwork for this year's My Homecourt project because of the artist's use of text and language in compelling and powerful visual motifs. This court mural commission presents a unique opportunity for the artist to create on a larger scale than ever before with inspiration from a distinct and diverse neighborhood."

Harada says of the court, "the basketball court is a place to form new relationships through play, further strengthening the communities that use the court and park."

As she developed the court mural design over several months, Harada remained true to her overall body of artwork. LET'S PLAY, combines bold text in multiple languages on a bright yellow field, each an invitation to join and play. The text painted on the court looks like letter-pressed type, reminiscent of that in early newspapers and print advertising. Yellow numbers surround the edges of the court in a vibrant pink field, referencing points and scoring. Combining this with inspiration drawn from communities surrounding Davis Park, Harada's mural design expresses the multi-faceted cultures through language of the folks who use the court as well as the unique message of the commissioned artist.

## **ABOUT LOIS HARADA**

Lois Harada is an artist and printmaker working in Providence. She studied printmaking at the Rhode Island School of Design (RISD) and settled in Rhode Island after graduating with a Bachelor of Fine Arts in 2010. She works at DWRI Letterpress, a commercial letterpress printshop where she also prints her own work. Harada has exhibited her work across the United States and internationally. Her work is included in private collections as well as the RISD Museum. Her practice is bolstered by residencies and she recently completed a residency at Anderson Ranch in Colorado in the spring of 2022. She recently finished a seven year term on the board of New Urban Arts, a nationally recognized free, arts drop-in program and a term as a city commissioner on the Art in City Life Commission serving the city of Providence.
